


#### Consolidated Revenues



### Consolidated Gross profit




### Consolidated Operating expenses




## Consolidated Operating margin






#### Consolidated Net income

## Consolidated Net income margin










#### Sales Revenue & Net Income










#### 2025Q1 Sales Revenues by Product Type






#### Comparison of Sales Revenues by Product Type




